Evropska povelja o lokalnoj samoupravi

- Zaključena pod okriljem Saveta Evrope dana 15.10.1985. u Strazburu
- Ratifikovana od strane Narodne Skupštine Republike Srbije donošenjem Zakona o ratifikaciji Evropske povelje o lokalnoj samoupravi (“Sl.glasnik RS – Međunarodni ugovori” br.70/07) na šestom vanrednom zasedanju dana 23.07.2007.godine, stupila na snagu 02.08.2007.
- Definicija lokalne samouprave: Lokalna samouprava predstavlja pravo i sposobnost lokalnih vlasti da, u okviru zakonskih ograničenja, uređuju poslove i upravljaju bitnim delom javnih poslova pod svojom odgovornošću i u interesu lokalnog stanovništva.

Zakoni koji uređuju lokalnu samoupravu:

- **Zakon o lokalnoj samoupravi:** uređuje vrste, organizacionu strukturu i nadležnosti jedinica lokalne samouprave, odnos jedinica lokalne samouprave sa državom i njenim organima, kao i sudsku zaštitu prava na lokalnu samoupravu
- **Zakon o lokalnim izborima:** kojim se uređuje postupak izbora za odbornike u lokalnim skupštinama, organi koji sprovode izbore i zaštita izbornog prava.
- **Zakon o teritorijalnoj organizaciji Republike Srbije:** koji određuje područja i sedišta jedinice lokalne samouprave, postupak za promenu granica tih područja i postupak za obrazovanje novih i ukidanje postojećih jedinica lokalne samouprave.

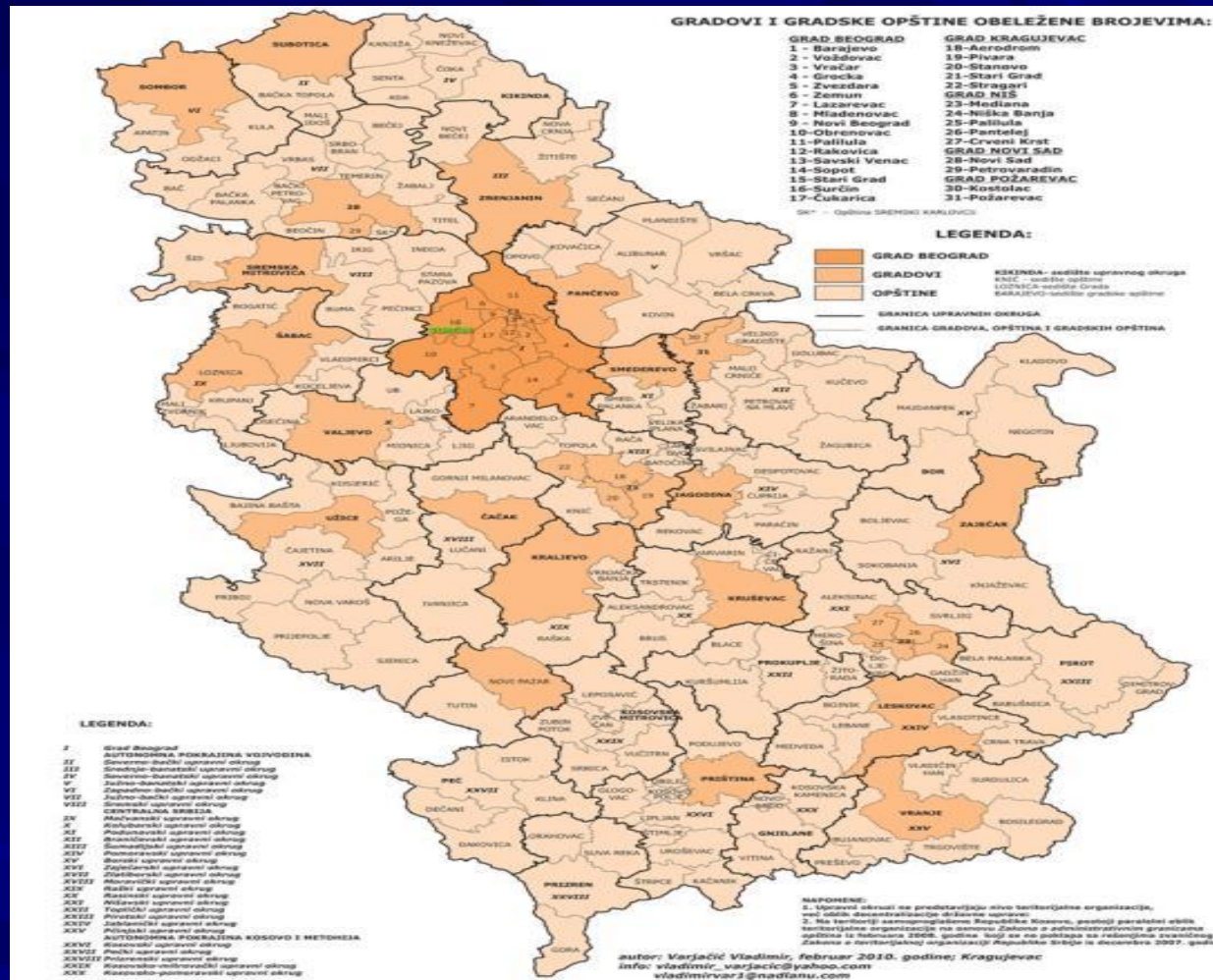
